- "Zombie Apocalypse", the Fall play (grades 1 -3) was led by Jocelyn Picket and Katelyn Miller.
- The county-wide Steam Practicum will be held at BCS tomorrow. The focus will be on how to implement Project Based Learning units.
- Both North and South campuses Halloween parades were a success.

1. Highlights from China Trip

Lisa Stone, Joseph Starke, Maddie Lee, Ethan Chang and Ryan Agdassi reported on the 8th grade China trip

- Students presented what they learned about the Chinese culture.
- Hosts went out of their way to accommodate students.
- Highlights included visits to a panda research center, a moon bear sanctuary, schools in Chengdu and Dujiangyan, a cooking class and cultural home visits with student buddies.

2. BSC 2016-17 CAASPP Results

Vice Principal Jen Anderson-Rosse provided an overview of BCS’s 2016-17 results:

- CAASPP Test administered in grades 3 – 8 and includes 4 test areas in English Language Arts/Literacy and 3 test areas in Math.
- Results available to the public on CDE School Dashboard.
- BCS’ results increased in ELA, while Math held current or decreased slightly.
- BCS outperformed all LASD schools in all categories (ELA, Math, English Learner, Students with Disabilities) and in all grades.
- An important BCS parameter is “We don’t teach to the test”, so these results are accomplished through a robust Project-based learning environment and integrated curricula at every grade level.
- BCS’ customized middle school math program supports understanding and math achievement in grades 7/8.
- Jen also reported on the new CAST California Science Test
 - New, computer-based test to replace CST
 - Next Generation Science Standards aligned
 - Spring 2017 - pilot test
 - Spring 2018 - field test
 - Spring 2019 - operational test
